4. **COURSE REQUIREMENTS (30 points for attendance + 70 points for written exam)**

A/SEMESTER:

- ◆ Keep the tutorial time
- ◆ 100% active participation ⇒ **!!! Active concentrated attendance without usage smartphones and notebooks → in the case of non-observance of the rule, the student will be excluded from the course!!!**
- ◆ Lecture structure:
 - ⊗ 2x student's presentation (one presentation 15min.)
 - ⊗ The enterprise's presentation (one presentation 60min.)
- ◆ Student presentation ⇒ **30 points:**
 - ⊗ According to the selected topic → the content related to
 - the theory from literature, journals and newspapers
 - the competitive environment of the enterprise (specifics of business subject in the branch of the business, the biggest competitors, ...)
 - not direct information about the presenting enterprise!
 - ⊗ Duration of the presentation → 15 minutes maximally
 - ⊗ Evaluation (in points) after both presentations

- ⊗ **Conditions for the presentation:**
 - *Team workgroup of maximum 3 people (One topic for a maximum of 1 group)*
 - *Content (100%) related to:*
 - *The newest theory (definition, classification, comparison official opinions,...) with resources, references and citations, including expression of the personal student opinion (70%)*
 - *Best practice of the competitive environment of the enterprise → not direct information about the presenting enterprise! (30%)*
 - *It will be applied to preparation of small book about most important theory in the area of the presented topic*
 - *Structure of the presentation (1/Introduction of the team; 2/Introduction of the topic; 3/Content of the presentation; 4/ Descriptions, explanations, observations; 5/Results; 6/Summary; 7/Vote of thanks)*
 - *Quality of the presenting performance → evaluation in points (from 0 to 30 points)*
 - *Communication and discussion with the audience*
 - *Minus points for reading → it is better to improvise*
 - *Request of the mandatory time (15 min. → after 15 minutes you will be stopped)*
 - *Presenting students must be in the lecture room (C1.07) 5 minutes before the beginning*
 - *Evaluation in points (from 0 to 30 points)*
