4. **COURSE REQUIREMENTS (30 points for attendance + 70 points for written exam)**

A/SEMESTER:

- ◆ Presentation ⇒ **30 points:**
 - According to the selected topic – the content related to the presenting enterprise (with its information) and its branch of the business/the biggest competitors
 - Duration of the presentation –15 minutes maximally
 - Lecture structure:
 - 2x student's presentation (one presentation 15min.)
 - The enterprise's presentation (one presentation 60min.)
 - **Conditions for the presentation:**
 - *Team work – group of maximum 3 people (One topic for a maximum of 1 group)*
 - *Content related to the business of the presenting enterprise (with actual enterprise information) and its competitors*
 - *Structure of the presentation (1/Introduction of the team; 2/Introduction of the topic; 3/Content of the presentation; 4/ Descriptions, explanations, observations; 5/Results; 6/Summary; 7/Vote of thanks)*
 - *Information from theory and practice*
 - *Example of the best practice*
 - *Expression of the personal student opinion*
 - *Quality of the presenting performance*
 - *Communication and discussion with the audience*
 - *Without reading - it is better to improvise*
 - *Request of the mandatory time (15 min. → during the 15 minute you will be stopped)*
 - *Presenting students must be in the lecture room (C1.07) 5minutes before the beginning*
