WHAT IS A SUPPLIER? - ROLE - AND HIRE?

Suppliers is the person or company who provides all the materials and services needed for building projects. The term 'supplier' encompasses a very diverse range of roles, duties, and skills. The best suppliers are reliable and efficient, and as a result, they have great relationships with their clients.

The role of a supplier can revolve around materials or services. For example, a building company may use an external supplier to source the following materials: timber, tools, windows, frames, and roof tiles. They can also supply – and sometimes recommend – the machinery needed for a project.

Does the supplier have a good reputation and referral rate?

Which companies use the supplier? (If tier one and two building companies use them, then it's safe to say that they are efficient).

Are they a niche supplier, or can they supply everything you need? (If they do, this will save you a lot of time in the long run!)

Do they supply good quality materials and machinery?

Do they guarantee they can meet your deadline?


How are they priced in comparison to other suppliers?

SUPPLY CHAIN MANAGEMENT

Companies have reduced the number of suppliers they buy from in order to <u>develop long-</u> <u>term, mutually beneficial strategic partnerships</u> with key suppliers.

Resellers share **close ties** and **strategic information** with suppliers to **optimize mutual benefits** of <u>satisfying the needs of the end customer</u>.

SCM stems from the reality that if the end customer is not satisfied, **nobody** in the supply chain wins.



ELECTRONIC DATA INTEGRATION (EDI)

In the <u>strongest of supplier relationships</u>, resellers even share confidential or closely guarded inventory systems and data with suppliers.

This means the reseller links its computer systems to those of suppliers.

This indicates when the distribution center or certain stores have reached critical levels on inventory.

This allows for optimized and efficient inventory replenishment.





SUPPLIERS

Manufacturers, wholesalers, retailers and service businesses rely on suppliers for basic business equipment and resale goods. Though a supplier benefits from the profit it makes by selling to you, trusted relationships with core suppliers also give value to your company. Thus, acting responsibly in supplier relationships is important to your success.



PLANNING SPEAKING

It is important to offer suppliers a fair opportunity to earn your business through open communication. That's especially true if you use multiple suppliers in similar categories. While you don't necessarily want to take open bids in every situation, it is important to act honestly to keep suppliers interested in doing business with you. Letting a supplier know you are going somewhere else for a certain purchase is an example of that kind of openness



PAYING MOMENT

Some buyers take suppliers for granted when it comes to paying invoices. Don't repeat their mistake. Not only do you need to pay for what you buy, you should do so in a timely way. Some suppliers extend you credit to induce purchases. When you get the invoice, you might have a 30- or 60-day turnaround. You often get a modest discount with an even faster payment, the supplier's way of thanking you in cash.





SOCIAL RESPONSIBILITY

Social responsibility is necessary in a business world where customers have access to efficient technology and communication tools. If you act irresponsibly in the way you operate, it doesn't take long for word to spread. Your suppliers, buyers and partners may suffer guilt by association if you are dishonest, irresponsible or unethical. As such, you have a virtual obligation to act responsibly to protect the companies that supply you. If you inappropriately or illegally use supplies or products, for instance, the public may also blame your suppliers.





SUPPLIERS DEVELOPMENT

Though it's not an obligation, some trade buyers take on the responsibility of supplier development. This strategy often fits into an integrated supply chain where you view suppliers as virtual partners. Supplier development can include more formalized and structured relationships with the core supplier, economic and intangible support of the supplier's operation and management and workforce training. Global companies like McDonald's and Starbucks often engage in supplier development to gain support from foreign governments.


