# 1. What is Environmental Compliance?

- a. Compliance- "conformity in fulfilling official requirements" (Webster's dictionary)
- b. Environmental compliance- "a **situation** in which a **company** or **organization** is obeying all the **laws relating** to the **environment**" (Cambridge dictionary)
- c. Running a company completely legal





- Environmental compliance has become a bigger and bigger concern in recent years, and will only get bigger as environmental concerns grow.
- Environmental laws try to keep damage and pollution to an absolute minimum.
- Businesses have to conform to **environmental laws**, regulations, standards and other requirements such as site permits to be allowed to operate.

## 2. Organizations

Environmental compliance varies from place to place ⇒ rules and regulations mandated might be enforced by city, county, state, or federal environmental agencies.

- Global Policy-Making Organisations (e.g. UN with UNEP-Environment Programme; ECE with Food and Agriculture Organization (FAO) and the International Maritime Organization (IMO))
- Treaty-Management Organisations (management of specific global, regional or subregional resources)
- Ad-Hoc Conferences, Committees and Subsidiary Bodies (e.g. General Assembly Resolution 47/188 of 22 December 1992- combat desertification)

# Permits, laws, regulations

Environmental laws, standards, and certifications regulate the environmental impacts associated with industrial activity.

- **Pollution Control laws**
- **Natural Resources laws**  
(Waste disposal; Air emissions; Water pollution; Chemical and biocide registration; Oil and gas storage)
- E.g.
  - Law 2008-46 Forestry Code (RO)
  - Act No. 238/1991 - on the Collection of Waste (SK)
  - Ley 2003 - 37 del Ruido (on noise) (ES)
  - Law 1964-12 on Water Pollution by Oil (TR)

# 3. The Importance of Environmental Compliance

---

- It's not just about following rules, it's more than just helping nature
- Being compliant is extremely important for our planet and it will give a very positive image to the company
- Essential to protecting profits and limiting the company's exposure to litigation and penalties
- Getting more clients



# Being Environmentally Compliant

---

Environmental compliance includes;

- Meeting requirements to obtain by conforming with disposal regulations
- Managing monitoring programmes or schedules
- Ensuring that the monitoring required in the permit has been done
- Processing, performing calculations and validating the data for compliance with any alert or reporting levels
- Generating routine compliance reports for authorities
- Providing training to employees

# Being Environmentally Compliant

---

1. First step is to figure out which rules and regulations apply to you
2. Companies should;
  - have formal environmental policies
  - keeping permits from the state environmental authorities
  - make sure they follow the rules

The biggest reason of “to be environmentally compliant” is you have **no choice**

# Who is Responsible?

---

- Many companies hire third party consultants to monitor to compliance for health and safety
- Environment department in the company - in such a case of manufacturing industries which are proceeding raw materials



# 4. Obstacles in Environmental Compliance

---

- Miscommunication between departments with respect to environmental requirements
- Not properly maintaining equipment
- Loss of institutional knowledge
- Lack of transparency and public confidence
- Being unaware of changes to a specific rule
- Using modern technologies in limited
