#### **WELCOME SPEECH**



#### **Lenka Surotchak, Director of the Pontis Foundation**

Lenka graduated from Comenius University in Bratislava in Journalism and also from New York University in Management. After working for a couple of years in the Slovak Press and Information Service and Slovak Television she started at the Slovak National Agency for Foreign Investment and Development (SNAZIR). Since then her career has been linked with NGO sector and philanthropy. In 1995 she held the position of program officer at the Foundation for a Civil Society (FCS) in Slovakia and since 1998 she has been Chief Executive Officer of FCS in New York focusing on management, supervising and fundraising for the Foundation's programs in Central and Eastern Europe and in the Balkans. Lenka is currently Director of the Pontis Foundation. She led the foundation through the process of institutional restructuring, developing a new programmatic and donor portfolio, created a corporate philanthropy strategy and provided supervision in the establishment of the Business Leaders Forum in Slovakia, Democratization and Development Abroad portfolio and interactive donor platform. She also carried out training in different areas of transitional know-how, institutional capacity building, internal NGO management, cross-sectoral cooperation, building up corporate donor strategies for different target groups in Slovakia, the Balkans and the Middle East.

#### **OPENING REMARKS**



## **Peter Burian, State Secretary of the Ministry of Foreign and European Affairs of the Slovak Republic**

He has lifelong experience in the field of diplomacy as well as domestic politics. After graduating from Oriental Studies at St. Petersburg State University (Russia), he worked for the diplomatic mission of the Czechoslovak Socialist Republic in Lebanon from 1987 till 1989. Later, after completing his education at the Diplomatic Academy in Moscow (Russia), he worked at the Embassy of the Slovak Republic in Washington (USA), where he eventually became Ambassador Extraordinary and Plenipotentiary in 2008. He has served in numerous foreign and domestic posts related to international security and diplomacy and was appointed Permanent Representative of Slovakia to the United Nations. He has served in his current position since April 2012.

## PLENARY SESSION: Enhanced Cooperation of the V4 countries: coordination in development

#### **Peter Hulényi,** Director of the Department of Humanitarian and Development Aid, Ministry of Foreign and European Affairs of the Slovak Republic

He is a carreer diplomat and has been working for the Ministry of Foreign and European Affairs (MFEA) for almost 20 years. A graduate from the Slovak Technical University in Bratislava (Master in Automatic Control Systems) and the Comenius University (Bachelor in Journalism), he held various diplomatic positions at the MFEA headquarters and abroad. He was posted as second secretary to the Slovak Embassy in Ottawa and as deputy head of the Slovak Mission to OSCE in Vienna, he also served as head of the Economic Cooperation Unit and as director of the Diplomatic Academy of the MFEA. Seconded by the UNDP and the Canadian International Development Agency CIDA, in 2002, he was entrusted with building the foundations of an institutional and strategic framework for the Slovak official development assistance (ODA) system. After completing this task he became the first director of the newly established Development Aid Department at the MFEA. Since 2002 his professional carreer has been closely linked with SlovakAid, being a member of ODA Steering Committees, Project Commissions and the Supervisory Board and closely cooperating with SlovakAid partner countries. He has broad publication activities in the area of development cooperation.



# **Ádám Zoltán Kovács,** Deputy State Secretary for international cooperation at the Ministry of Foreign Affairs and Trade of Hungary

Since 2012 Ádám Zoltán Kovács has served as the head of Department of International Relations of the Ministry of Rural Development of Hungary. Before holding this position he worked as an expert on international relations and CEO of a company focusing on trade and tourism. He studied international relations at the Zsigmond Király College and subsequently finished his master degree in regional and environmental economy at the Szent István University in Gödöllő, Hungary.





#### Ivan Juki, Director General of the Economic Section, Ministry of Foreign Affairs of the Czech Republic

He started his studies at the Czech Technical University in Prague in the field of economy and management of energy systems and continued in various programs and trainings in France, the UK, Japan and Denmark. He has held his current position of Director General of the Economic section at Ministry of Foreign Affairs of the Czech Republic since 2012. Prior to that he was CEO of Czech Trade Promotion Agency. Between 2000 and 2006 he served at the Embassy of the Czech Republic in Denmark as commercial counselor. He started his carreer at Vatech EZ where he held different positions including Head of international relations department.

## **Ingrid Brocková,** Ambassador, Permanent Representative of the Slovak Republic to the OECD

Ingrid Brocková became Permanent Representative and Ambassador of the Slovak Republic to the OECD in October 2011. She was nominated from the position of Director of the Department of EU Policies at the Ministry of Foreign and European Affairs of the Slovak Republic, where she had worked since May 2009. During the years 2001-2008 she was Country Manager of the World Bank in the Slovak Republic. Prior to that, she had been working at the Ministry of Foreign and European Affairs of the Slovak Republic since 1993 holding various positions, including assignment at the Embassy of the Slovak Republic in Washington (1996–2000). Throughout all years of her professional career she has dealt with international public economic policy. Ingrid Brocková graduated from The Paul Nitze School of Advanced International Studies John Hopkins University in Washington, USA and the Slovak Technical University in Bratislava, Slovakia.



#### **Martin Heather, Policy Officer in the European Commission**

Martin Heather is a Policy Officer in the European Commission for the Directorate–General (DG) Development and Cooperation – EuropeAid, where he works on the post-2015 sustainable development framework and particularly on peace and security, growth, industrialisation, jobs and disaster risk reduction issues. Martin is a seconded national expert from the UK Departmental for International Development (DFID) where he has worked for eleven years in a wide variety of roles, including: leading and managing a fragile states and conflict policy team, including working on post-2015 issues; holding a corporate role in the cross-Government UK Stabilisation Unit; a programme management and policy role in Afghanistan; and

a policy role in a Ministerial Private Office. He holds a Master's in Development Administration and Planning from the University of Bristol and a degree in International Relations from Aberystwyth University.

## **Jeroen Verheul,** Ambassador for Trade and Development of the Kingdom of the Netherlands

Jeroen Verheul has lifelong experience with development cooperation and foreign affairs. Since 1985 he has worked for the Ministry of Foreign Affairs of the Netherlands where he has held various positions related to his expertise working in different countries such as Ethiopia, Cameroon, Zambia and France. He recently started as Ambassador at large for Aid and Trade solving different issues such as integrating and synergizing aid and trade agendas and preparing the Netherlands presidency of the EU in 2016. Before joining the Ministry of Foreign Affairs he worked at the European Parliament where he was in charge of conducting a study into the role of the European Union in enhancing coordination of development cooperation. He obtained his Master's degree in Public Administration.



#### Ida McDonnell, Policy Analyst at the Review and Evaluation Division, OECD

Ida joined the peer review division in 2008 where she has been the lead analyst for eight peer reviews of DAC members' development co-operation. The most recent reviews she worked on are Ireland, Australia and Switzerland. Ida has contributed to a number of OECD studies on civil society and development as well as to Managing Aid: Practices of DAC members (OECD, 2008). Before 2008, Ida was a policy analyst at the Development Centre of the OECD (from 2000-2008) and contributed to one of the Centre's flagship annual publications The African Economic Outlook; she co-authored the publication "Public opinion and the fight against poverty" (2003) and co-ordinated the OECD-DAC informal network of Development Communicators (2004-2008). In 2003-2004, Ida was an attaché for development at the Permanent Representation of Ireland to the OECD and UNESCO; during Ireland's Presidency of the EU. Ida holds a Masters of Development Studies, from University College Dublin (1999) and a BA in European Studies (economics and politics) from the University of Limerick (1997).

## **Simon Lightfoot,** Senior Lecturer in European Politics, University of Leeds

Before he came to Leeds in 2005, Simon worked at Liverpool John Moores University. His PhD was awarded in 2002 from Nottingham Trent University. He has been a visiting fellow at the National Europe Centre, Australian National University and the Corvinus University of Budapest. He is co-organiser of the EADI Working Group 'Development Aid of the Non-DAC Donors'. He has an interest in learning and teaching issues. In 2009 he won the Political Studies Association's Bernard Crick Prize for Outstanding Teaching and was awarded a full University Teaching Fellowship. In 2013 Simon won the prestigious award of National Teaching Fellow from the UK Higher Education Academy. He is co-editor of 'Development Policies of Central and Eastern European States (with Ondrej Horký-Hluchán) and 'Teaching Politics and International Relations' (with Cathy Gormley-Heenan).



#### **Patryk Kugiel,** Analyst at the International Economic Relations and Global Issues Programme, Polish Institute of International Affairs, Poland

He graduated from the Jagiellonian University in Krakow, majoring in International Relations and Comparative Religion Studies. He also studied in La Sapienza University, Facolta di Studi Orientali in Rome and did his M.Phil. in South Asian Studies at the Jawaharlal Nehru University in New Delhi. Since 2008 he has been a research fellow at the Polish Institute of International Affairs (PISM) in Warsaw, where he is responsible for research on South Asia and international development cooperation. His areas of expertise include Poland's development cooperation system, European development cooperation policy, V4 countries cooperation on development issues as well as development challenges in Asia and Africa.



# **Zsuzsanna Végh,** Research assistant at the Center for EU Enlargement Studiwes, Central European University in Budapest, Hungary

Zsuzsanna Végh has been research assistant at the Center for EU Enlargement Studies of the Central European University in Budapest since 2012. Her research interests include foreign policy of the European Union and the V4 countries, with particular attention to the EU's Eastern neighborhood. More recently she has also been focusing on the international development policies of the Visegrad countries as part of their foreign policy. Since 2011, she has been cooperating with the European Council on Foreign Relations as national researcher of the European Foreign Policy Scorecard. Zsuzsanna holds a Master in international relations and European Eu

pean studies from the Central European University (2012) and a Master in international studies from the Eötvös Loránd University in Budapest (2011).

#### Ondřej Horký-Hlucháň, Head of the Research Department, Institute of International Relations in Prague, Czech Republic

His main research interest concerns the development policy of the Czech Republic and other Central and Eastern European countries. #### **Anne-Marie Callan,** Ambassador of Ireland to the Slovak Republic

Anne-Marie Callan is Ambassador of Ireland to the Slovak Republic. From 2011 -2013, she was a Deputy Director in the Development Cooperation Division of Ireland's Department of Foreign Affairs and Trade with responsibility for cooperation with civil society organisations and volunteering. From 2009 to 2011, Anne-Marie was Chargé D'Affaires of Ireland's diplomatic mission in Sierra Leone and managed Ireland's development programme in Sierra Leone and Liberia. Prior to her departure to Sierra Leone, Anne-Marie held the position of Deputy Director in the Development Cooperation Division of Ireland's Department of Foreign Affairs and Trade with responsibility for Zambia, Zimbabwe, Eastern Europe, Central Asia and the Balkans. Anne-Marie was Deputy Permanent Representative to the OECD and Deputy Permanent Delegate to UNESCO in Paris from 2002 to 2006. She was elected Vice Chair of the OECD's Development Assistance Committee in 2005. Anne-Marie has held various roles in the Department of Foreign Affairs and Trade and the Office of the Revenue Commissioners since beginning her career in 1986. She holds a Master's Degree in Peace and Development Studies from the University of Limerick and a Bachelor of Business Studies from Dublin City University.

## Ivana Raslavská, Program Director, Democratisation and Development Abroad

Ivana Raslavska has been program director of the democratisation and development department since 2011. She finished her PhD. at the Faculty of International Relations, University of Economics in Bratislava in 2008. Her main professional interests are development cooperation and global education and in the past she also worked actively with teachers, students and youth on intercultural issues and global citizenship topics. #### Andrea Girmanová, Project Manager, Slovak NGDO Platform

Andrea Girmanová has been working on Slovak and European development policy and awareness raising activities within the Slovak NGDO Platform since 2011. She graduated in Economic Diplomacy at the Faculty of International Relations, University of Economics in Bratislava. She spent part of her studies at the European University Viadrina in Germany and University of Liège in Belgium with a focus on development and population. As a volunteer she was involved in the projects of local NGOs in India (women empowerment, HIV/AIDS prevention) and Ethiopia (children in difficult situations, income generating activities). #### Ilina Nesik, Project and Communication Manager, Balkan Civil Society Development Network, Macedonia

Ilina Nesik has considerable international experience as the holder of a Master's degree on Strategic Communications and Public Relations from the European Studies Centre in Nancy and by being active in several organizations in France, the Balkans and Germany. Her area of expertise includes EU Integration Process, lobbying and advocacy, communications, campaigning and organization of high level international events as well as project management. She authored several DCED publications, including on lessons learnt and good practice in donor partnerships with business. Melina studied Political Science, Development Economics and International Law at the University of Bonn/Germany, the University of Geneva and the Graduate Institute of International and Development Studies in Geneva/Switzerland.

#### **Georg Schoen, Venture Coordinator Austria & CEE,** Ashoka, Austria

Georg Schoen works for Ashoka – the global association of the world's leading social entrepreneurs. He supports social entrepreneurs across Central Europe to maximize their impact and helps building ecosystems for social entrepreneurship by creating alliances with the public, private and not-for-profit sector. Georg studied at the University of Vienna, the Vienna University of Economics and the Vienna University of Technology. He has worked for think tanks and research institutes in Central America and Austria, and published widely on topics related to sustainable development and social change. Georg was UNDP Environment Programme Officer in Macedonia, and set up the UNDP Black Sea Climate & Business (CLIMBIZ) Initiative. The CLIMBIZ Initiative launched the first regional Scaling Challenge for social and environmental entrepreneurs in this region, supporting ventures from Serbia to Azerbaijan to scale-up.



#### **Gunther Schall,** Head of Unit Private Sector and Development. Austrian Development Agency

Gunter Schall works at the Austrian Development Agency, the operational unit of the Austrian Development Cooperation. As head of the "private sector and development" unit he is in charge for both private sector development in ADA's partner countries and ADA's business partnership program. Prior to that, he worked as a Policy Advisor for the Federation of German Industries (BDI). Dr. Schall holds a PhD of the University of Freiburg.





# ROUNDTABLE F: Democracy Assistance: How to Ensure that the EU Plays a More Active and Principled Role in Supporting Democracy, Freedom and Human Rights in a Changing Geopolitical Climate



## **Miriam Lexmann, Director of EU Office, International Republican Institute**

Miriam was actively involved in the Slovak civil society movement during the years of post-communist oppression in the late 90's. She brought her expertise to the international level, when working for the Council of Europe on civil society development programmes. Her primary focus was mainly on the former Soviet Countries and the Western Balkans. After Slovakia joined the EU Miriam served as the Permanent Representative of the Slovak Parliament to the EU. Following her advisor position in the European Parliament, she joined the International Republican Institute as the Director of its EU Office in Brussels. She is Member of the International Board of the Transatlantic Christian Council and actively involved in the Slovak non-profit sector. Miriam holds a Master degree in Philosophy and is a PhD candidate at the Institute of European Studies and International Relations at the Comenius University in Bratislava.



## **Jerzy Pomianowski,** Executive Director, European Endowment for Democracy, Brussels

After two years as Deputy Foreign Minister of Poland, Jerzy Pomianowski is leading the newly founded European Endowment for Democracy, as its Executive Director since January 2013. Prior to leading the Polish Foreign Service's democratisation agenda, Pomianowski worked for the joint international initiative of the United Nations Development Programme (UNDP) and the Organisation for Economic Co-operation and Development (OECD): Partnership for Democratic Governance. As its Director (2008-2011), he supported countries destabilised by armed conflict or natural disasters. This followed his work as Director General of the Polish Foreign Service (2005-06) and his launch of Poland's Development Cooperation and Aid (2006-08). Pomianowski began his career as a civil servant in 1990, just after the fall of communism, first in the Ministry of Education, and then in the Ministry of Foreign Affairs. After being in charge of Poland's relations with Asia, Middle East and Africa, he was Ambassador to Japan from 1997-2002. From 1980-89, Pomianowski was an active member of the democratic opposition in Poland. He was a board member of the Independent Students' Association and co-founder of the students' independent publishing house during his Sociology studies at University of Warsaw.

# THE INTERNATIONAL VISEGRAD FUND ROUNDTABLE G: V4 and Eastern Partnership: What small scale assistance can give to small countries?



#### **Balázs Jarábik,** Associate Fellow, Central European Policy Institute, PACT

Balázs Jarábik was a civic activist in Slovakia in the nineties; from 1999 he worked with the Pontis Foundation on civil society development projects in the Balkans and the Commonwealth of Independent States (CIS). He also consulted international organizations, governments and the European Parliament on issues connected to Central and Eastern Europe and has written extensively about the region. Working for a Pact, a US NGO in Kyiv, Ukraine over the past six years he has helped to develop and supervise the largest civil society support program in Eastern Europe. He is also a Senior Fellow at the Central European Policy Institute (CEPI) in Bratislava and an Associate Fellow at FRIDE, a pan-European think tank based in Madrid and Brussels.



## **Eka Tkeshelashvili,** President, Georgian Institute for Strategic Studies

Until recently Eka Tkeshelashvili has been the Vice Prime-Minister, State Minister of Georgia for Reintegration. She previously served as the National Security Adviser to the President of Georgia and as the Secretary of the National Security Council of Georgia. Earlier she held the position of the Minister of Foreign Affairs of Georgia. She also served as the Prosecutor General of Georgia and the Minister of Justice of Georgia. Mrs. Tkeshelashvili also held the position of the Chairperson of Tbilisi Appeals Court. Mrs. Tkeshelashvili has master's degree in International Human Rights law from Notre Dame Law School (USA), certificate in human rights lawyering and human rights advocacy from Oxford University (UK), Diploma in Law from Tbilisi State University.



## Karla Wursterová, Executive Director, International Visegrad Fund

Karla Wursterová is the Executive Director of the International Visegrad Fund. The mission of the International Visegrad Fund is to promote development of closer cooperation among the Visegrad Group countries – the Czech Republic, Hungary, Poland and Slovakia. Ms. Wursterová has been the head of the fund since August 2012. She served as Second Secretary at the Embassy of the Slovak Republic in Prague (2005–2009) and held the position of Director of the Department for Development Assistance and Humanitarian Aid at the Slovakian Ministry of Foreign Affairs (2009–2012). She graduated in Business Management at the University of Economics in Bratislava and Ecole Nationale d'Administration Publique in Paris.

#### **Krzysztof Stanowski,** Executive Director, Solidarity Fund, Poland

From 2007–2010 he held a position of Deputy Minister of Education and from 2010–012 was Deputy Minister of Foreign Affairs. He graduated of History at the Catholic University in Lublin. During the communist era he was regional leader of underground Solidarity and political prisoner. Since 1989 he co-founded and led various non-governmental organizations including Education for Democracy Foundation and Zagranica Group. He also served as a member of Steering Committee of the Civitas International (1975–2000) and the World Movement for Democracy (2000–2007). He is considered to be experienced international trainer and educator active in Poland, Eastern Europe and Central Asia. He is author of educational programs and publications on NGO management and civic education. In recognition of his social and educational activities he was presented with Mongolian "North star" medal as well as Polish Order of Polonia Restituta.



#### Vladislav Kulminski, Political Adviser to the Prime Minister, Government of the Republic of Moldova

Prior to this Vladislav worked with United Nations Development Programme in Moldova as a Programme Manager for the 'Support to Confidence Building Measures Programme' which aimed to coordinate confidence building measures between Moldova and the Transnistrian region. As a John Smith Fellow in 2010 his action plan was to implement a new long-term strategy to help resolve the conflict. In his previous position he was able to do this by coordinating and managing a 'Confidence Building Measures Programme for Moldova and the Transnistrian region' in an environment where few meaningful contacts between the sides existed or were functional. He also led a team of sectoral experts in designing, planning, implementing, monitoring and evaluating joint projects in a range of conceptually diverse areas. Through this he was able to negotiate with and involve a wide range of stakeholders, experts and officials from both sides to promote joint programs, remove obstacles to implementation and fine-tune programme activities which would match the development priorities of both sides in this "frozen conflict" environment.


