- Change the name of the company.
- Ensure directors don't go beyond their powers.

# "Voting rights"



The right to vote is a shareholder's most essential entitlement. Corporations are required to convene annual general meetings at which shareholders can be apprised of the company's progress.

During the meetings, shareholders propose and vote on various issues calculated to facilitate the progress of the corporation.



# Importance of information

Proper books of accounts = accurate picture of the position of the business.

Annual reports must cover every aspect of the business to give the shareholders comprehensive information that they can use to make decisions about the future of the company.

- Shareholders have a right to be presented with audited financial statements during the annual general meeting.

Receive descriptions of all transactions and statements

Be informed about all the costs

Receive accurate and timely statements

Be provided with descriptions of Fidelity's policies and practices

#### Responsibilities

Consider all investments

Communicate with their financial representative

Keep their accounts current

Use the right resources

#### CSR to shareholders and investors

- 1. Disclosure of information: Give the investors and shareholders the **proper information** and **transparent information**, normally given in annual reports, or quarterly reports.
- 2. Communication and relationship: The company to not only give information, but also **communicate about future plans**, CSR activities etc.
- 3. General Meetings: This is in the shareholders part, the company has the responsibility to **inform** when and where are the **general meetings**, and **council elections** for long term decision making and CSR.




