Lukáš Parízek

State Secretary of the Ministry of Foreign and European Affairs of the Slovak Republic

Lukas Parizek became the State Secretary of the Ministry of Foreign and European Affairs

of the Slovak Republic in March 2016. Prior to that, he held positions in the Slovak Innovation and Energy Agency and the Ministry of Defence of the Slovak Republic, where he worked in the Bilateral Relations and Defence Assessment Sections. He gained professional experience from Organization for Security and Co-operation in Europe (OSCE) Secretariat in Vienna, Austria, where he worked for the Action against Terrorism Unit. Lenka Surotchak

Executive Director, Pontis Foundation

Lenka Surotchak graduated from Comenius University in Bratislava in Journalism and also from New York University in Management. After working for a couple of years in

the Slovak Press and Information Service and Slovak Television, she started her career at the Slovak National Agency for Foreign Investment and Development (SNAZIR). Since then, her path has been linked with the NGO sector and philanthropy. In 1995, she held the post of program officer at the Foundation for a Civil Society (FCS) in Slovakia and since 1998 acted as the Chief Executive Officer of FCS in New York focusing on management, supervising and fundraising for the Foundation's programs in Central and Eastern Europe and in the Balkans. Lenka Surotchak is currently the Director of the Pontis Foundation. She led the foundation through the process of institutional restructuring, developing a new programmatic and donor portfolio, created a corporate philanthropy strategy and provided supervision in the establishment of the Business Leaders Forum in Slovakia, Democratization and Development Abroad portfolio and interactive donor platform. She also carried out trainings in different areas of transitional know-how, institutional capacity building, internal NGO management, and cross-sectoral cooperation, building up corporate donor strategies for different target groups in Slovakia, the Balkans and the Middle East.

A Belgian Jean-Louis De Brouwer is the Director of Operations in the European Commission's Humanitarian Aid and Civil

Protection department (ECHO). He joined ECHO in November 2012, having previously served as a Director in charge of the coordination of employment politics in the Commission's department for Employment and Social Affairs. Prior to that, he spent 18 years in the Justice and Home Affairs department, specialising in migration and asylum questions, and later he was a Director in charge of border and visa issues. Before joining the European Commission, Mr De Brouwer worked in the Belgian civil service (the Ministry of Economic Affairs and the Ministry of Home Affairs). He has Masters Degrees both in Law and Sociology from the Catholic University in Louvain, where he also completed his undergraduate degree studies in Political Sciences. He is a lecturer in International Relations and EU Affairs at the same university.



Michal Mlynár

Director General for International Organisations, Development Cooperation and Humanitarian Aid, Ministry of Foreign and European Affairs of the Slovak Republic

Ambassador Michal Mlynár currently

serves as Director General for International Organisations, Development Cooperation and Humanitarian Aid at the Ministry of Foreign and European Affairs of the Slovak Republic. In addition to this, he serves as the Chair of the Governing Board of DCAF's International Security Sector Advisory Team (ISSAT) in Geneva, Switzerland. He is a former Ambassador of Slovakia with residence in Nairobi, Kenya (2012-2015). He has been part of Slovakia's Foreign Service since September 2000. He twice served as the Deputy Chef de Cabinet for the Slovak Foreign Minister (2002-2004 and 2010-2011) and a head of units at the UN Department and at the Diplomatic Protocol of his Ministry. As the Deputy Permanent Representative of Slovakia to the United Nations in New York (2004-2009), he was the Political Coordinator of Slovakia's diplomatic team on the UN Security Council (2006-2007). In 2013, he was elected the Chair of the Committee of Permanent Representatives (CPR) to UN-Habitat in Nairobi for the 2014-2015 biennium.



Zuzana Števulová

Director of the Human Rights League

As the Director of the Human Rights League (HRL) – Slovakia's premier NGO providing legal and other assistance to foreigners – the attorney Zuzana Števuľová has emerged

as the country's most prominent advocate for refugee and migrant rights. In a country where the majority of asylum applications are rejected, she has won numerous cases at Slovakia's Supreme Court on behalf of her clients in expulsion and asylum proceedings. Since the beginning of Europe's migration crisis, Števuľová has been a strong and unwavering voice for greater assistance to and compassion for refugees. She has not shied away from criticizing the anti-refugee and anti-Muslim rhetoric of certain politicians and regularly challenges social prejudice and fear by introducing Slovak citizens to refugees who have successfully integrated into the Slovak society.



Natalia Alonso Deputy Director of Advocacy

& Campaigns - Advocacy Offices

Natalia Alonso is the Deputy Director of Advocacy and Campaigns of Oxfam Inter-

national managing the influencing work of the Advocacy Offices in Brussels, Geneva, New York and Washington. In her role, Natalia oversees Oxfam's advocacy and campaigning towards the EU, UN and IFI institutions. In Brussels, Natalia and her team coordinate the work across Oxfam's in 8 European countries, and thus foster an ambitious EU response to climate change, food security, tax justice, humanitarian crisis and development aid. In addition to this, she functioned in Brussels as the head of the EU office at the Plan International and as the Deputy Director at the Amnesty International's EU office. Natalia Alonso, a graduate from Agricultural Engineering, has over 15 years of experience in development and human rights issues, with 9 years working experience overseas, in India and the Dominican Republic, for the European Commission and INGOs.



Seamus Jeffreson Director of CONCORD

Seamus Jeffreson has been the Director of CONCORD, the European NGO Confederation for Relief and Development since 2014. He is an experienced international develop-

ment and humanitarian programme manager, with over 20 years of working experience in strategy, programme development, analysis and reporting, project management, technical assistance, training and representation. Previously he worked for 8 years in Ethiopia and the Middle East with various NGOs including the International Medical Corps, CARE, Trocaire and Cafod. He also acted in Brussels for several years working on Eastern Europe and the Balkans, including some time spent at the European Commission.

Dr. Michal Vašečka is a sociologist by background and operates at the Faculty of Social Studies of Masaryk University in Brno since

2002. He focuses his interests on issues of ethnicity, race, and migration studies. He operated at the New School University in New York and at the University of London as a visiting scholar. He also lectured at the Georgetown University in Washington, DC and at the University of Michigan in Ann Arbor. In 2016, he was a scholar-in-residence in the ISGAP at Oxford University. Dr. Vašečka is a founder of the Center for the Research of Ethnicity and Culture, he served also as the director of the CVEK. From 1998 to 2005, he operated at the Slovak think-tank Institute of Public Affairs as a program director on expert analysis of the Slovak transformation process with a focus on national minorities and the state of civil society in Slovakia. He has been a consultant for the World Bank. Since September 2012, Dr. Vašečka serves as a representative of the Slovak Republic in the European Commission against Racism and Intolerance (ECRI), the human rights body of the Council of Europe; and since 2010, he is a chairman of the Board of the Fulbright Commission in Slovakia. Dr. Vašečka serves also as a non-resident research associate at the European Centre for Minority Issues in Flensburg.

Alaa Murabit

Voice of Libyan Women, UN Sustainable Development Goals Global Advocate

Alaa Murabit is a UN High-Level Commissioner for Health Employment and Economic

Growth, one of only 17 Sustainable Development Goal Global Advocates appointed by the UN Secretary General, and a MIT Media Lab Director's Fellow. Her TED Talk "What my religion really says about women" was "Talk of the Day" & one of four "moving TED Talks to watch right now" as claimed by New York Times. At the young age of 15, Murabit graduated from high school and moved from Saskatoon, Canada, to Zawia in Libya. It was there that she completed her studies at a medical school and, driven by her desire to create inclusive processes and institutions, she founded the Voice of Libian Women in 2011, at the age of 21. With a strong focus on challenging societal and cultural norms and by utilizing traditional and historical role models, Murabit champions women's participation in peace processes and conflict mediation. Her programs, such as the ground-breaking Noor Campaign, have been replicated internationally. Nicknamed "The Libyan Doogie Howser" by Jon Stewart and applauded for her innovative and inclusive approach to security, Murabit has become a champion for inclusive peace processes, and acts as an advisor to numerous international security boards, governments and organizations, including her service as a board trustee for International Alert and Keeping Children Safe. An Ashoka Fellow, Murabit is the youngest Marisa Bellisario International Humanitarian Award recipient, New York Times "International TrustWomen Hero 2014", Newsweek's "25 under 25 to watch", a BBC "100 Top Woman" and SAFE "Global Hero".

environmental change in the developing world. He is a PopTech Fellow, a Tech Awards Laureate, an Ashoka Fellow, and a National Geographic Emerging Explorer. He has been internationally recognised for his technology-based work. In 2013, he was nominated for the TED Prize and, in 2015, he was a Visiting Fellow at RMIT University in Melbourne, Australia. In late 2015, Ken was appointed the CARE International's first Entrepreneur in Residence. He is a founding member of the Slovak NGDO Platform and served as its chairman and later on as a board member. He has been actively involved in setting up of the Slovak ODA system.

Miodrag Milićević is the Executive Director of NGO AKTIV and has over a decade of work experience and extensive knowledge of national, regional and international affairs,

elections, institution building and non-governmental institutions. He was born in Pristina in 1971 where he completed his undergraduate studies at Faculty of Law. He is the chairman of the editorial board of the political talk show Sporazoom, a member of TACSO and the Civikos Platform in Kosovo. He was a co-author of the programme "Facilitation of Republic of Serbia Parliamentary and Presidential elections in Kosovo" delivered in 2012.
