#### **Overview**

The Shine program offered by Swiss Re in association with BOOKBRIDGE, a social enterprise, and Pontis Foundation, a leading NGO nurturing social innovators, will support ideas that address challenges in any of the areas of Climate Smart Agriculture, Access to Health, Environmental Sustainability, Economic Inclusion through innovation for societal resilience, pertaining to any region in Slovakia. These areas are in addition to the on-going focus area of education from Swiss Re Bratislava. We will select an aspiring/early stage entrepreneur based on his/her holistic understanding of the social challenge and innovative approach to the solution, among other parameters.

This innovator will then undergo a six-month immersive program during which he/she will collaborate with experts, business coaches, and leaders in Swiss Re to develop a financially feasible and scalable business plan. Following this, the progress of this new social enterprise will be monitored to analyze impact.

We are positive that this experience will not only help the winner realize his/her vision but also help the person grow professionally and personally.





#### **Social Innovator Award**

The ideas presented by the applicants will be evaluated and a winner shall be chosen, who will then move to the next phase. To mark this achievement, the winner will also receive Swiss Re's Social Innovator Award with a prize money of 5 000 EUR.

#### Evaluation topics: Innovation / Social impact / Business model





#### **Action Learning Program**

The social innovator will team up with Swiss Re employees to design, implement and evaluate a tangible social enterprise. In the six-month part-time Action Learning Program, they will together define customer needs, develop a viable business plan, pitch it in front of the Shine Panel of Experts and aim to earn a funding of 15 000 EUR. During this process, they will be accompanied by a professional business and leadership coach in an open workshop setting. The Action Learning Program will be delivered in collaboration with BOOKBRIDGE.



### **Structured Learning Process**

Action learning program is split into four modules spanning 6 months as detailed below:




#### 12 days over 6-months part-time

In-between modules, candidates will spend 3-4 hours per week on virtual teamwork. The above structure is indicative and likely to be adapted to to prevailing COVID-19 situation



#### Impact assessment


Swiss Re will monitor and evaluate the performance, impact and sustainability of the social enterprise to ensure stability and growth.








### **Time schedule**
